
Missouri Stream Team

I am trying to round up some volunteers to join the water monitoring efforts of the Missouri Stream Team. I think this would be great for Lake Tishomingo. The "classes" involve two 8-hr days of classroom and lab. That covers the intro-

ductory and Level 1. This would be instruction in taking water samples, testing, and identifying little aquatic critters. Sounds like fun. Would you be interested?

At a meeting of the Belews Creek Watershed Management Partnership Monday I received a go-ahead on the proposed water monitoring program proposal for adding Lake Tishomingo to the proposal being put together for monitoring Belews Creek. Assuming that we are awarded the full grant we will be especially interested in what is flowing into Lake Tish from the surrounding area, from our own mainte-

nance yard, from Lake Bono Del, and upstream from there. Participation with Stream Team is the best way to get the sampling equipment (free) and the training.

The LTPOA sponsors lake testing for presence of

coliform bacteria. We have volunteers working with the Lakes of Missouri Volunteer Program monitoring water temperature and nutrient levels. Add this Stream Team water monitoring and it should give us a pretty good picture of the health of the lake.

If you would consider joining into this program, access http://www.mostreamteam.org/ and wander through this site and give me your thoughts (274-4245, clents@charter.net). A few sampling bottles, a few snacks, a jug or two of wine...we could revolutionize the philosophy of water quality sampling.



President's Report

Joe Hejnal reported on the construction of the extension (extended 6ft.) to the maintenance shed. President Townsend would like the board to review Nova's initial proposal and compare with the work that was done to make sure it was done to spec.

Marilyn Meyer thanked Matt Schweiss for cleaning the roads and ditches after all the big rains.

Matt Schweiss reported that some of the roads on the South side of the lake need to be patched before the weather gets cold.

Janet Hirsch reported that the minutes of the last meeting are on the website and the website was updated with the color version of the newsletter. The newsletter was mailed on November 2 and the next issue deadline is December 20, 2009.

Renee Kittel reported that the Angler's Association has an invitation for the St. Louis Skeet and Trap in Pacific at 11:00 a.m. on December 5 for one round of sporting plays. Bring a gun and 4 boxes of shells for \$35. Contact John Johnston for information.

Sewer Committee

Janet Hirsch reported on the sewer project. Janet stated that we are still waiting for approval of plans by USDA-RD and the district is working on administrative items such as writing ordinances for sewer use and sewer charge and setting up bookkeeping systems and hiring a CPA for audits. If there is anyone who would like to help the district with any of these items, they would really appreciate it.

Gate

Russ Wilner reported on the gate function. Four vehicles were struck by the ingate or the outgate arm in the last month. Two of the vehicles will need repairs, paid for by the Lake and the Lake's insurance. The last person whose vehicle was struck by the gate arm was able to remove the yellow paint left on his vehicle. The gates have intermittently gone into "dance" mode and have reached a point of being unreliable. So the Gate Committee decided that it would be best to leave the gate arms up until the

equipment can be updated. Even if the current problem with the gates could be fixed, there are enough other problems (difficulty in accessing the gate computer via telephone, gate occasionally locks up for no reason, gate real-time clock doesn't work), that the system really does need to be updated.

Janet Hirsch stated that the Gate Committee looked at the software for one updated gate system and it was not as flexible and easy to use as the current software. More research needs to be done on the different gate systems and software that's available. All systems seem to be competitively priced at approximately \$12,000. We have money in the budget to pay for the gate upgrades.

Rich Hirsch stated that the limit switches were most likely causing the gate to go into "dance" mode. Dance mode is when the gate cycles up and down continuously.

In the interim, it was decided that an insulated round PVC pipe would be used as a gate arm to cushion it and prevent any problems that might arise out of the gate striking a vehicle. Gate Committee member Mike Leiweke volunteered to sketch the new bracket that needs to be made and send it out to a shop for construction.

Security

Rick Hannick read aloud his November Security Report: Just a couple of items to report this month.

There have been no security-related incidents that I am aware of with the exceptions of the gate problems that I know you are already dealing with.

I cut the guard's hours to 12 per week, effective the weekend of October 17-18, so the lower hours should be reflected in the

October billing cycle from Stryker. I contacted seven security companies by phone, and two more by e-mail regarding our need to replace Stryker Security at the beginning of next year. That was two weeks ago, and not one of them has responded with a bid. I guess no one wants to provide part-time security for us. Any suggestions?

Rich Hirsch reported that the portable toilet has not been picked up yet. It was supposed to be gone on October 24 and we should not have to pay for the extra time it has been here.

Janet Hirsch reported that in A-13 there is a submerged motor boat which is a hazard for boaters and an environmental hazard that is sticking out of the water. The owner of the lot is in a nursing home. President Townsend stated that he would call the owner's children to check the status and see what the board could do to help remove the boat from the water.

There being no further business, a motion was made by Marilyn Meyer and seconded by Joe Hejnal to adjourn. Motion passed. The meeting concluded at 8:01 P.M.

Building

John Hindrichs reported on a potential project on the north side in O-cove. The property owner would like to build a parking pad and wanted to know if it had to be paved. John told him that it would need to be paved upon completion and to submit his building permit.

Maintenance

Joe Hejnal reported that the snow plow is ready to be used. Joe also stated that he spoke with Kevin Seelbach and Kevin is applying for the permit to install the electric service in the new maintenance shed. Joe mentioned that he spoke with the builder of the new addition on the maintenance about the question of the footing. The builder told Joe that they went deep enough to hit solid rock and it is secure.

Matt Schweiss reported that it is too cold to do anything with the repair of the roads and that it will be an additional \$3,200 to address the issues and we should wait on the project until the spring or summer.

Joe and Matt discussed the bobcat and how the buckets are rusted due to the salt usage. Joe stated that the bobcat was power washed each time it was used last winter and they agreed that the bobcat should be power washed after each use as a standard procedure.

Matt also stated that the perimeter of the roads needed to be addressed and would like to rent a bush hog in the next couple of months before spring.

Security

Rick Hannick read aloud his security report for December. **DECEMBER 8, 2009 SECURITY REPORT**

Still peaceful, I'm happy to report. I received one report of a possible prowler on the north side last month, but there have been no further reports regarding this incident.

As you know, we will lose Stryker Security after Dec. 31. I have had no success in generating interest from other security companies. I am waiting for a call back from Raintree regarding their efforts to find a replacement for Stryker. It would seem that no one is interested in only working Friday and Saturday evenings, and only 10 or 12 hours per week. Maybe we will have to do without a guard until spring when we increase the hours to 24 hours/week. The increased hours might then encourage some company to bid for a contract with us.

Hopefully, the security gate will be fully operational by the end of the year, and I would again like to encourage the board to close it 24/7.

Red Algae

If your lake takes on the rich, deep red color of wine in autumn, don't immediately run to the store for cheese and crackers. What you are witnessing is probably an algae bloom. *Planktothrix rubescens* (formerly known as *Oscillatoria rubescens*) is a species of blue-green algae (a.k.a. cyanobacteria) that can have a very distinctive red color. Additionally, the cells can attach end-to-end and may form filaments of several millimeters in length, making them easily visible to the naked eye. During winter this algae may even seep through fissures in the ice, creating colorful "flowers" across the lake's surface.

For much of the year *P. rubescens* resides near the metalimnion, that transition area between the warm epilimnion and the colder hypolimnion (see "Lake Stratification" below). *P. rubescens* blooms are frequently reported in fall when lake temperatures cool and the water column starts mixing deeper. This change in lake thermal structure doesn't necessarily promote the bloom of *P. rubescens*, but rather moves the bloom from the metalimnion to the surface. The colorful algae become apparent once this metalimnion has mixed with the cooling surface layer of the lake.

Like many blue-greens, *P. rubescens* is capable of regulating its buoyancy, effectively moving itself up and down within the water column. When high in the water column they receive enough light to photosynthesize.

During photosynthesis, they produce dense carbohydrates that eventually weigh the cells down, causing them to sink. Once in deeper water (sometimes the hypolimnion) where there isn't enough light to photosynthesize, *P. rubescens* will respire, using the carbohydrates for energy, thus lightening their load. A by-product of their respiration is the expansion of their "gas vacuoles". Eventually, with enough respiration, the gas vacuoles increase buoyancy enough to lift the algal cell back up in the water column.

P. rubescens has adapted to life in the summer metalimnion by tolerating cool temperatures and low light. The cool, dark and deep water of the hypolimnion tends to have more nutrients, thanks to settling particulates and the release of nutrients from the sediment (see "Phosphorus From Within" Fall 2006 Water Line). While in or near the hypolimnion, *P. rubescens* takes advantage of the higher nutrient levels by stocking up. Thanks to its tolerance of low-light conditions, *P. rubescens* has an advantage over the algae that are restricted to the epilimnion where nutrient concentrations are lower and competition is higher. Even during turnover, when the water column is mixed, this blue-green competes well under low-nutrient conditions. As a result, its presence in lakes with low nutrient concentrations can be prolonged, highlighting the contrast between the clear water state before turnover and the sudden, startling appearance of the red bloom.

P. rubescens is capable of producing two kinds of toxins; a neurotoxin (which affects the nervous system) and a hepatotoxin (which affects the liver).

However, *P. rubescens* does not produce these toxins at all times. It is not well understood why *P rubescens* or and other blue-green algae sometimes produce toxins. To be safe, avoid swimming during any algae bloom, red or green.

Density of P. rubescens During Stratification

This graph shows three variables (temperature, light, and *P. rubescens*) as they relate to lake depth. The top and

bottom of the graph represent the surface and bottom of the lake, respectively.

The topmost arrow is at the Secchi depth, 12 feet. About 20% of the sun's light penetrates to this depth. The temperature is the same as at the surface (about 74°F), and there is no red algae present.


At 36 feet (the second arrow), there is no sunlight, the temperature is much cooler

(about 40°F) and the density of *P. rubescens* is the highest. This depth marks the bottom of the metalimnion, where there is likely access to a supply of dissolved phosphorus from the nutrient-rich hypolimnion.

Lake Stratification

Many people, especially fisherman, have heard of "turnover," which occurs when lake water mixes from the surface to the bottom. Less well known is what is happening during the rest of the year. When a lake isn't "turning over" it becomes stratified.

A volume of water is heaviest at 39.2° F, just above freezing. The same volume of water becomes lighter as it warms and rises to the surface, leaving the colder water at the bottom (except in winter-see below). As the sun continues to heat the water at the top, the difference in temperature (and density) between the top and

bottom water becomes greater. Eventually there are two distinct layers, the epilimnion at the top and the hypolimnion at the bottom.

Lake Tishomingo Community Sewer Project

Approval of Plans & Specs

All of the sewer design plans and specifications have been submitted and we are awaiting final approval from MO DNR and USDA-RD, our funding agencies. Shortly after the plans are approved the project will be advertised for contractors to bid on.

As reported previously MO DNR has approved the plans. USDA-RD is still reviewing the plans and has asked for changes. The changes have been made and the plans resubmitted and our engineers await additional comments. Construction was previously estimated to begin mid-November, but the USDA review of the submitted plans has taken a very long time. We expected one to two months for the entire review to be completed, but so far it's been six months. So the schedule will be pushed back even further. We estimate that construction will begin no sooner than April or May 2010.

Electrical Circuits

We are close to having the specification for the electrical circuit required at each residence and believe it will be:

Circuit: 120v 20amp dedicated circuit terminating in a service disconnect in a NEMA 3R enclosure.

Access Road

The District is seeking to gain access to the wastewater treatment plant site using a temporary construction road off Regina Rd. If we do this we avoid having construction vehicles drive across the dam and eliminate much of the congestion and wear due to construction vehicles on N. Lakeshore Dr. Negotiations continue with the property owner.

Administrative Tasks

The District has to establish an accounting system for receiving funds from the USDA and MO DNR and for paying the contractors. We have arranged for a CPA firm for audits and an accountant to help set up the bookkeeping system.

The District needs someone to do the billing and bookkeeping. This represents an opportunity for part time work for a lake resident. It is a work-at-home paid position. Requirements are a computer with internet access and experience with Microsoft Word and Excel. Accounting or bookkeeping experience is a plus. If interested please contact Marilyn Meyer.


Between these two layers is a third, less distinct, transition layer called the metalimnion.

These layers generally hold until autumn, when the surface water cools.

Often in the summer, the hypolimnion will become depleted of oxygen. The bacteria responsible for decomposition consume the oxygen and access to atmospheric oxygen is cut off by stratification.

Water Freezes from the Top Down

One would assume that if water becomes more dense as it gets colder, it should freeze from the bottom up. As explained earlier, however, water is most dense at 39.2° F, which is warmer than freezing. So as water continues to cool from 39.2° F, it becomes less dense and rises to the top, leaving the slightly warmer water below.

At the surface, the cool water is exposed to freezing air temperatures and may eventually freeze. Once ice forms,

the water beneath cannot be mixed by the wind.

When the ice melts in the spring, the entire water column will be at approximately 39.2° F for a brief time. The lake will mix thoroughly ("turnover") with just a bit of wind. A calm, warm day can heat the surface water and initiate the stratification process.

Stratification may also occur due to changes in salt content as well as temperature. Oceans, particularly in places where freshwater enters, may be stratified by salinity. The problems with Gulf Hypoxia may be attributed partially to the inability of the dense and salty bottom water to mix with the oxygen-rich, less salty water above.
