2016 4th of July Fireworks Display REGULATIONS


The state fire marshal has set a 500 ft. SAFE ZONE during the set-up until after the display. This means that the "A & I" coves will be off-limits to non-residents of these coves. The residents leaving and entering those coves will be required to do so using a route closest to the shoreline as indicated in RED on the map.

The SAFE ZONE will be marked with a line of buoys. DO NOT ENTER THIS AREA!!! The fireworks will begin at 9:30pm. It is MANDATORY that we follow the fire marshal's request or the display WILL BE CANCELED. Thanks in advance for your cooperation, the LTIA Board.

As April comes to a close things at the Lake are preparing for a FUN & SAFE Summer. Please re-read the Water Activities Rules & Regulations found on our website by clicking on Rules & Regulation on the top left hand side of the home page, then click Fishing & Water Use Rules.

Two of the most noticeable abuses are

- no running lights at night
- pontoons not obeying the no wake rule.

Another item is driving with your docking lights on. This blinds the on-coming boaters. It's like driving your car with the high beams on. Please be safe, courteous, & helpful to all boaters again this summer.

The water patrol boat is just like a policeman, never there when you need them, but remember, we are all patrol men & women on OUR Lake. If you see someone doing something incorrectly, please be nice, and remind them of our rules.

The construction of the" Water Relief Overflow System" should start soon. This area is located at the inlet creek where the large rocks are located and will be roped off while this construction is being done. Please be careful when you are around this area.

Well it's that time of the year again when a quick thunderstorm could drop 1" or 2" of rain in a short period of time. So let's be proactive and make sure that our ditches are free & clear of leaves and debris, to allow the runoff a free path to the lake.

Several years ago the Building Rules & Regulations were amended to include the paving of every driveway. These are items 10 & 12 below. We have had some new construction in our community, which is a very good thing for the lake, & look forward to additional updates

Sewer Board Needs a Volunteer

After many years of service a director is soon retiring from the sewer board. And we need someone to volunteer for this board position.

The board's main function is to oversee the operation of the sewer system. And the result is the safeguarding of the water quality and beauty of the lake.

Since sewer system began operation in 2011 we have seen an obvious improvement in the water quality of the lake. We have had fewer algae blooms and water clarity is better than it has been in the last 15 or more years.

As a board member you will be making a substantial contribution to your community. There is no special knowl-edge or experience required.

The directors meet monthly to review the sewer system operation and financial reports. Directors frequently interact with the treatment plant operator and homeowners to answer questions and provide assistance. There is no heavy lifting required :-)

The monthly meetings are held at 5pm on the third Tuesday of each month in the Sales Office, 5706 N Lakeshore Dr.

- #10 Within one year of the completion of any construction, all driveways, parking areas, etc. shall be paved with asphalt, concrete, or permanent hard surface. If a culvert is required, as determined by building director, said culvert shall be a minimum of 12 inches in diameter and shall be installed at the proper grade to insure adequate drainage of all ditches.
- #12 Every driveway must be paved for the first 20 feet from the lake road.

This October we will begin lowering the lake to approximately 6 feet below full pool. This will facilitate boat ramp improvements, dock repairs, sea wall repair & construction, silt removal, as well as any other type of activity that requires less water in the lake. Please prepare now by contacting your contractor and our building director, Doug Leeker, with your detailed blueprints & site maps. If you are in need of a contractor the board has knowledge of those contractors that residents have used in the past.

As we are doing our spring cleaning and come across items made of metal or iron that we don't know what to do with, please contact Brandon Eckstein at 636-725-5795. Brandon will be happy to help you with the disposal of such material.

Annual Meeting and Election Saturday June 18, 2016

The annual meeting of the Lake Tishomingo Property Owners Association will be held June 18, 2016 at 11:30 a.m. at the Community House. After the meeting the voting for the election will begin. The polls will remain open until 2:30 p.m. Directors will be available for your questions.

Ballot Items

Lake Tishomingo News

- Two positions on the LTPOA Board of Directors
- Ballot issue concerning changing the regulations to allow relocation of a path subject to strict requirements.

To place your name on the ballot

- 1. The candidate must be a lot owner in Lake Tishomingo Subdivision.
- 2. All 2015 assessments must be paid in full including any lien fees, interest, and attorney fees.
- The candidate must submit a letter, in person or by mail requesting his/her name be placed on the ballot giving full name, mailing address, block letter and number in the subdivision owned by him/her to the election commissioner. Last date a filing can be accepted is May 18, 2016.

To vote in person

- 1. All assessments must be paid and up-to-date by June 17, 2016.
- Present property owners must be recorded on the LTPOA assessment books by 1:00 p.m. June 17, 2016. Only one person can vote for co-owned lots.
- 3. Your ballot will be marked with the number of votes you will cast.
- 4. The number of votes is determined by the size of your lot (one vote for each ten front feet, but not less than five or more than ten per platted lot).

To vote by absentee ballot

- To obtain an absentee ballot you must send a self-addressed stamped envelope to Ann Schatzman, the election commissioner, at 7741 Meadow Dr, Hillsboro MO 63050.
- 2. Include your name and lot number(s) owned by you.
- Your completed ballot must be received by the election commissioner on or before 2:00 p.m. June 17, 2016 for it to be counted with the regular ballots for the June 18, 2016 election.

WATER ACTIVITIES RULES AND REGULATIONS

(Revised 2011 By LTPOA Board)

I. FISHING

- 1. Fishermen must be accompanied by a lot owner except by special arrangements made with the lake patrol.
- 2. Fish may be taken using a rod or pole. Only three rods or poles per person are allowed, and there is a three hook limit on each rod or pole.
- 3. Trotlines and jugs are prohibited.
- 4. The maximum number/quantity of fish per take, creel, catch or possession shall be according to the Tishomingo Anglers Association's current recommendations in accordance with the continuing effort to improve and modify each species and their population. These regulations are formulated after consulting our local fisheries biologist. (See creel limits on next page.)

II. PATROL BOAT

- 1. The LTPOA patrol boat operator is responsible for water safety and enforcement of Water Activities Rules and Regulations and Boat Registration and Regulations.
- 2. The patrol boat will be operated in a safe and courteous manner and has the right-of-way on the lake at all times.

III.BOAT & MOTOR IDENTIFICATION

- 1. All boats must be registered with the LTPOA and must be the property of a lot owner.
- 2. Registration stickers will be furnished for those boats in compliance with the LTPOA Boat Registration Rules and Regulations. Stickers must be placed on the left (port) side of the craft near the block and lot identification.
- Boats of all types must have the owner's lot and block number placed on each side of the craft in letters not less than three (3) inches in height. Placement should be toward the front of the boat if possible.

IV. BOATS

All boaters must be in compliance with Missouri State Rules and Regulations

- 1. The maximum boat length allowed is seventeen (17) feet excluding pontoon boats.
- 2. No boat shall be overloaded beyond the OBC rated capacity, or have a motor that exceeds the OBC maximum rating.
- 3. No hydroplanes, jet skis, inboard motor, or air boats (swamp buggies) are allowed.

V. PONTOON BOATS

- 1. Pontoon boats cannot exceed 24 feet in length.
- 2. No such type of craft shall be permitted unless the owner has a residence at Lake Tishomingo.
- 3. No such craft shall have any temporary or permanent sleeping, cooking, sanitary or toilet facilities thereon. No enclosing or screening of craft.
- 4. Pontoon boats are restricted to "No Wake" (a very slow speed whereby the wake or wash created by the vessel would be minimal).

VI. MOTORS

1. No craft shall have attached a motor which exceeds a total of forty (40) horsepower.

VII. MOTOR BOATING

- 1. From 10.00 a.m. until 7:00 p.m. (prevailing time), maximum speed allowed.
- 2. From 7:00 p.m. until 10:00 a.m., all crafts shall be restricted to "No Wake" *(a very slow speed whereby the wake or wash created by the vessel would be minimal).*
- During ski hours all boats are to maintain a marine pattern of counter-clockwise travel.

- 4. Zigzagging, facing toward the stern while operating boat, reckless speed, operating craft while intoxicated and any other form of careless or reckless operation is prohibited.
- 5. Minimum clearance of freeboard from gunwale to the surface of the water while operating shall be six (6) inches for any craft.
- 6. Every craft must be equipped with an approved type of life preserver for each person aboard.
- 7. Boats operating after dark must be properly lighted.
- 8. All boating must be at least 100 feet from shore.
- 9. Right-of-way shall be in the following order: sailboats, row boats, canoes, pontoons.
- 10. No boats are to enter swimming area under any circumstances.
- 11. Reduce speed of all craft while in coves or launch area to "No Wake" (a very slow speed whereby the wake or wash created by the vessel would be minimal)
- 12. If you see or think that anyone is in distress, make effort to help and notify patrol boat.

VIII. SKI AND SURFBOARD SAFETY

- 1. Skiing or surfboarding is permitted from 10:00 a.m. until 7:00 p.m. (prevailing time).
- 2. Skier must wear an approved life saving belt or jacket at all times.
- 3. Keep boat and skier 100 feet from shore while operating.
- 4. All boats when pulling skiers must either be equipped with a rearview mirror or have at least two occupants.
- 5. Travel counter clockwise at all times and circle counter clockwise when picking up a fallen skier.
- 6. Never drive boat so that skier is closer than 50 feet from any object.
- 7. Take signal from skier only and never sit on gunwale of boat.
- 8. Operators of boats pulling skiers must be at least sixteen (16) years of age.
- 9. Skiing from cove entrance is not permitted. Skiing should start and end up on the main body of the lake.

IV. SCUBA DIVING

- 1. Any property owner or guest scuba diving must have card signifying accredited course in techniques of diving.
- 2. Report to the patrol approximate area where you intend to dive from.
- Display diver flag on float or boat and stay within 100 feet of same. Boats and skiers to keep 150 feet from flag. Remove flag after dive.
- 4. No scuba diving in ski lanes except when search and rescue diving is being conducted.
- 5. Fish and game Laws must be observed by divers.

X. SWIMMING

- 1. All swimmers must stay within fifty (50) feet of the shoreline except as noted below.
- Swimming from pontoon boats is permitted (for short periods of time) in the lane between swimming, 50 feet from shoreline, and the ski lanes, 100 feet from shoreline.

XI. BUOYS

1. No buoys/tethered objects may be used in Lake Tishomingo without LTPOA approval.

XII. RESPONSIBILITY

1. Lot owners will be held responsible for the actions of their guests.

grass out of the road on the back of the dam and will cut the grass on the dam when they are able to get back here.

Clarue stated that we would need to build a weir with sandbags to measure the water coming down the back of the dam to make sure we do not have a leak in the dam. Steve said he would get some volunteers to help construct the weir.

Clarue reported that she had applied for and received the permit to addle goose eggs from the US Fish and Wildlife Service.

Clarue stated that the groundhog holes look like there may have been some activity. Rich Hirsch said he set up the game camera a few weeks ago and didn't see any activity, but the groundhogs may have still been sleeping. He will set it up again.

Clarue reported that she would start the water testing in May before Memorial Day weekend.

Old Business

President Blaha asked Brian Stephens with the Anglers Club, if they had received any requests to have the water willow removed. Brian stated that they have only received one request. Steve asked Brian to run another notice in the newsletter.

ATV Rules

- All riders must wear safety helmets.
- No more than two riders on an ATV.
- All ATVs must drive on the right side of the road and yield to all other traffic.
- All ATVs must obey the 20 mph speed limit.
- All ATVs must remain off other people's property.
- No riding on dam or lakefront area allowed.
- No ATVs from outside the lake are allowed on lake roads or lake property.
- All ATVs must be registered with the board and have lot numbers and lake identification stickers.
- No racing allowed anywhere on lake property.
- All ATVs must be equipped with adequate muffler systems
- All ATVs must have proper headlights and taillights to be run at night.
- No ATVs allowed on the lake when the lake is frozen.

If you observe anyone operating an ATV on private lots or off-road lake property you can report the trespassing to the Jefferson County Sheriff: (636) 797-5000.

Lake Tishomingo Community Sewer Report

The district is seeking a volunteer to help with monitoring the sewer system and making business decisions.

Proper and efficient operation of our sewer system is vital to maintaining the quality of the lake. If you appreciate clean lake water you should consider serving on the sewer board.

Wanted: Board Member

After many years of service, Rick Lippitt soon will be retiring from the sewer board and we are asking for someone to replace him.

The primary purpose of the board is safeguard the water quality and beauty of the lake. by ensuring that the system operates properly.

The directors meet monthly to review the treatment plant and collection system

operations, Missouri One-Call, and financial reports. Directors frequently interact with the treatment plant operator and homeowners to answer questions and provide assistance.

The director qualifications are specified by Missouri law. The position is open to anyone at least twenty-five years old who has resided in the district for at least one year and is not delinquent in the payment of taxes or sewer fees.

There are many reasons to volunteer for this position. The best reason is to take your turn helping to maintain the quality of our lake water. As a result of the sewer system installation the water quality has improved dramatically. Proper oversight of the system operation will guarantee the continued improvement in water quality.

Everyone has something to contribute. Over the years many many people have served on the LTPOA and LTIA boards. Many also have volunteered for committees in these organizations. Now the sewer district is asking for help. The meetings are only once a month and generally last about an hour.

If you have questions about the director position contact any director listed above.

The next meeting of PWSD#13 is 5pm Tuesday March 15 in the Sales Office, 5706 N Lakeshore Dr. The board can change future meetings times to accommodate the schedules of participants.

Missouri One-Call

The District is a part of the Missouri One-Call System. (The system was formerly known as "Dig Rite.") Missouri law requires that any person making or beginning any excavation notify MOCS at least three but not more than ten working days in advance, except in the case of an emergency.

Proper and efficient operation of our sewer system is vital to maintaining the quality of the lake.

Placing a locate request is free and easy! Call 1-800-DIG-RITE (800-344-7483) or 811 or place your request online at http://www.mo1call.com.

Before you start any excavation project at your Lake Tish property you must notify Missouri One-Call to have the sewer and other utility lines marked.

Payment Options

Sewer user fees are due by the 10th day of each month. Sewer user fees are **delinquent** if not received by the district on the 21st day of the month. This does not mean "check date" nor "postmarked." It means **received by the district.** Any accounts with balances due on that date will be charged the late fee.

Homeowners are encouraged to consider automatic payment of the sewer bill. The invoice postcards are issued the first of every month and payment is due on the tenth of that month. Payments not received by the 21st of the month are delinquent and subject to lien and prosecution.
