- What is the First Right of Refusal?
- Why do I need to know about the FRR?
- When do I need to use the FRR?
- What does this really mean to me?

I have put together a short How-To on the FRR. Please keep the summary below and refer to the sample FRR letter shown on page 4.

# How to use the First Right of Refusal

Now that you have decided to sell your home or lots you will need to abide by paragraph #9 of the Lake Tishomingo Restrictions.

1. Get a potential buyer and enter into a contract to sell.

2. After you have a contract, you must send out the FRR letters to the adjoining lot owners and the LTPOA. You must list the lot's block letter & number that is for sale, the dollar amount, date of closing, current owner's name, and the name of the purchaser.

3. When the FRR form is filled out it is best to use certified mail, so that you will have a paper trail with signatures of receipt. Mail a copy to the LTPOA and the owners of the adjoining lots.

4. Once the letters are mailed you must allow the adjoining lot owners and the LTPOA 15 days to respond with their selection, either to purchase, or to decline to purchase. If you have not had a response in fifteen days, you may assume the adjoining lot owners are not interested in purchasing.

5. If you receive a response indicating an adjoining lot owner is interested in purchasing your property, you must disclose the terms of the contract to the adjoining lot owner, and they must exactly meet the terms of that contract. This includes the cost and closing date, and all additional terms.

6. Complete the sale.

## LTPOA Meeting Minutes June 2018

LTPOA Minutes June 12, 2018

Board members present, Mike Steeno, Jon Riche, Doug Leeker. -NO QUORUM PRESENT-

At 7:03 pm, Vice President Mike Steeno called the meeting to order. There were 10 residents in attendance, all recited the Pledge of Allegiance.

#### **President's Report**

Vice President Mike Steeno thanked everyone for coming. Mike stated the annual meeting would be this coming Saturday (June 16th). There are four open positions and four people running to fill the vacancies. Mike apologized to those in attendance because only three board members were present. This is highly unusual and without at least four members present the board does not have a quorum and cannot complete any formal voting. Mike explained that typically, we would approve the minutes from prior meetings and have the treasurer's report. However, we could not do so because of the lack of quorum.

#### Building

Doug Leeker reported on an application for lots F23, F24 and F35. The work to be completed is a rebuild of the existing deck, new seawall, sidewalk and patio. This work was previously approved over email is being put forth to be recorded into the minutes. Also, lot D12 has requested to complete a resurfacing of their boat dock. Doug stated he will ask for approval over email due to lack of quorum. Doug took his tour of the lake by land and by water and reported no issues.

Linda Coker's house was destroyed by fire. The board asked residents to donate gift cards (Wal-Mart, Visa, etc...) to help our neighbor in her time of need. Gift cards can be placed in the mailbox in front of the sales office.

#### Gate

Rich reported on the highest used codes for May. The code for Chris Townsend saw an increase in frequency over the month and Rich stated we should keep an eye on his code. No other unusual code activity was reported.

#### Newsletter

Doug discussed that the board is planning on mailing out the newsletter at least once a year. There are ongoing plans to mail hard copies of the July newsletter. The board feels like communication is becoming a problem and is considering alternative ways to keep residents informed.

#### **Old Business**

Mike discussed the upcoming planning and zoning meeting on June 14th regarding the sand mine. The board has sent out notices asking residents to attend the meeting. Mike has been involved with several parties (residents and non-residents) to oppose the sand mine. An LLC has been formed, several letters have been written, buttons and t-shirts have been made and there are more than 1,000 signatures on a petition, all opposing the sand mine. The planning zoning commission will make a recommendation and then the county council will make their decision.

Doug discussed the issue with several dead bass that have been found in recent weeks. We have been in contact with the Missouri Department of Conservation (MDC) and have had a representative out to look at the lake. Originally, it was thought that the bass were being killed by Large Mouth Bass Virus, which is something that all fish carry and can occasionally kill a larger number of bass. However, after further discussion with the MDC, the consensus was that the bass were killed by rising temperatures. Because of the cooler spring temperatures the bass make their nests in shallower waters in order to breed. When the temperatures finally rose this summer they did so quickly, making it very hot within a number of days. This caused a rapid increase in water temperatures. The bass are very territorial to their nests and do not leave, they cannot withstand the rising water temperatures and they die. This conclusion was confirmed by its occurrence at other area lakes. There was no evidence of the Large Mouth Bass Virus, or any other water contaminants.

#### New Business

A resident asked if the board would consider putting sand on the volleyball court. It was stated that we would discuss the topic at a later meeting.

#### Adjourn

Mike thanked everyone for coming again. Without a quorum, the board was unable to make a motion to adjourn.

# 2018 LTPOA Annual Meeting Minutes

LTPOA Minutes June 16, 2018, Annual Meeting

Board members present, Mike Steeno, Doug Leeker, Ken Stojeba, Shelby Reneski, Jon Riche.

At 11:30 am, Vice President Mike Steeno called the meeting to order. There were 20 residents in attendance, all recited the Pledge of Allegiance.

#### **President's Report**

Mike Steeno stated he was filling in for President Steve Blaha who could not be in attendance. Mike said filling in for Steve is hard to do, because Steve is a tremendous president who is always thinking ahead and puts in many hours. A round of applause was had for Steve.

Mike continued by reading the Presidents report prepared by Steve: Steve thanked everyone for taking time out of their busy weekend schedule to attend the meeting and cast their ballots. Four positions are open on the board of directors and four people have run for these positions, Roy Hummel, Ken Stojeba, Mike Steeno and Jon Riche. Steve thanked all the residents of the lake for sharing in the common goal of making the lake a great place to live. The lake has rules we all must abide by. Please visit the website at LakeTishomingo.com to read over the rules and respect them. Also, please make sure to be familiar with the water safety rules. Steve, went on to thank several volunteers from the past year including Rich and Janet Hirsch, Clarue and Martin Holland, Frances and Robert Hovis, Shelia Frauenfelder, Chyree De Roode, Kevin Scheirich, Ron Hacker, Ken Jost, Emmy Riche, Matt Holloran and Al and Rosie Ferrell. Steve stated we will be continuing with our annual road repair. Also, the lake will next be lowered in the fall of 2020 for silt removal. We are looking into alternative ways to handle the silt, with more information forthcoming. The TAA will be spraying water willow for any residents who would like it removed. Please contact the TAA if you are interested. The Missouri State Dam Inspectors have been on site and have found the dam to be in very good condition. The clubhouse patio and landscape were started in December 2017 and are now complete.

Mike gave and update on the sand mine. The planning and zoning committee has recommended to deny the zoning change that would allow the sand mine. The County Council will meet next to make their decision. Mike has been involved with several members of the community to fight the mine and everyone's efforts are very appreciated.

Ken noted that Mike Steeno, Janet Hirsch and Linda Blaha (among others) have put in countless hours and extended his thanks.

#### LTPOA minutes continued from previous page

Mike Steeno asked the board members if they read the minutes from last year's annual meeting and if they had any additions, corrections or deletions. With nothing new to correct or add, Mike asked for a motion approve them as printed. Shelby Reneski made a motion to approve the minutes and it was seconded by Doug Leeker. MOTION PASSED.

#### **Treasurer's Report**

Shelby Reneski read the financial report for May 2018. There was a cash inflow total of \$94.03 which included \$85.00 from gate cards and \$9.03 from interest. The checking account balance as of May 31, 2018 was \$67,196.92. The Major Projects Fund has an account balance of \$203,712.76 as of April 30, 2018. Interest accrued in the amount of \$86.51, leaving a balance of \$203.799.27 as of May 31, 2018. Ken Stojeba made a motion to accept the financial report and it was seconded by Jon Riche. MOTION PASSED.

Shelby Reneski asked for approval to pay bills totaling \$16,272, which included GCI Security (\$730), Ameren Utilities (\$123.3), Red Oak Landscaping for dam cutting and trimming the spillway (\$1,275), Happy Grass Lawn & Irrigation for multiple cuts around the lake and from the gate to the 4 way stop (\$1,170), Phone.com (\$18.33), Charter (\$59.99), Shelton Landscapes for final payment of community house landscaping (\$10,169.85), Tony, LLC for millings for the parking lot (\$2,100), the recorder of deeds to file liens on unpaid assessments (\$371.50), Advanced Pest Control for spraying of the sales office (\$30), Shelby Reneski for stamps for quarry letters (\$180), and Janet Hirsch for envelopes for quarry letters (\$43.76). Ken Stojeba made a motion to approve paying the bills and it was seconded by Jon Riche. MOTION PASSED.

#### **New Business**

One resident asked about Jefferson County spraying for mosquitoes. Another resident asked for a new basketball net on the basketball court. Ken stated he would look into the possibility of the mosquito spray and obtain a new net.

Emmy Riche, election commissioner, spoke and stated that there was no ballot measure this year and asked if anyone on the floor wanted run for the open positions. There were no volunteers.

#### Adjourn

With no further business to discuss, Ken made a motion to adjourn and it was seconded by Doug. The meeting adjourned at 11:56 pm.



## LTPOA Meeting Minutes July 2018

#### LTPOA Minutes July 10, 2018

Board members present, Steve Blaha, Doug Leeker, Ken Stojeba, Roy Hummel, Mike Steeno, Jon Riche.

At 7:04 pm, President Steve Blaha called the meeting to order. There were 11 residents in attendance, all recited the Pledge of Allegiance.

#### **President's Report**

President Steve Blaha mentioned the recent good news that the Jefferson County Council has voted unanimously to deny the zoning change for the sand mine. Mike Steeno gave an update on the meeting. The next potential hurdle is the sand mine representatives could file suit. Everyone involved is still monitoring the situation and is prepared if the suit is filed. So far things have gone as well as possible. Mike thanked all those who have helped with the opposition.

President Steve Blaha asked the board members if they read the April, May and June minutes and if they had any additions, corrections or deletions. The June minutes needed a correction of the month from January to June. With nothing further to correct or add, Steve Blaha asked for a motion to dispense with the reading of the minutes and approve them as printed. Ken Stojeba made a motion to approve the minutes and it was seconded by Mike Steeno. MOTION PASSED.

#### **Treasurer's Report**

Shelby Reneski was not in attendance, Jon Riche read the financial report for July 2018. There was a cash inflow total of \$100.02 which included \$80 from gate cards, \$13.14 from an insurance dividend and \$6.88 from interest. The cash outflow for June totaled \$15,977.26 and included the final payment to Shelton Landscape for the community house landscaping (\$10,169.85), Tony, LLC for the parking lot millings (\$2,100), recorder of deeds to file assessment liens (\$371.50), Mooney Landscaping for community center gutters (\$615), Advanced Pest Control for sales office (\$30), Happy Grass Lawn and Irrigation for 2 cuts from the 4 way stop to the gate (\$160), 3 cuts of the common ground (\$360) and a cut of the interior roadsides (\$650), Phone.com (\$18.33), Janet Hirsch for quarry letter envelopes (\$43.76), Red Oak Landscaping for mowing of the dam and spillway (\$1,275), Ameren (\$123.83) and Charter (\$59.99). The checking account balance was \$51,319.68 as of 05/31/2018. Interest accrued in the Major Projects Fund account in the amount of \$94.36, resulting in a balance of \$20,893.63 as of 6/30/2018. Steve asked for a motion to approve the July financial report. Doug Leeker made a motion to approve the report and it was seconded by Mike Steeno.

Jon Riche asked for approval to pay bills totaling \$5,619.22, which included GCI Security (\$3,513.13), Ameren Utilities (\$117.40), Phone.com (\$18.33), Charter (\$59.99), Steve Blaha for reimbursement of patrol boat fuel (\$40.55), Janet Hirsch for envelopes for the assessment letters (\$41.14), Shelby Reneski for assessment letter stamps (\$180), Brittons Quick Stop for gas (\$14.24), Rottler Pest for termite program (\$276), Happy Grass for mowing from the 4 way stop and common areas (\$590), Steve Blaha for artificial grass for the patrol boat (\$46), Doug Leeker for printing and postage for the mailing of the newsletter (\$694.34), Ken Stojeba for diesel fuel for Bobcat (\$28.10). Ken Stojeba made a motion to approve paying the bills and it was seconded by Roy Hummel. MOTION PASSED.

#### Building

Doug Leeker reported on an application for a new concrete apron and turn around asphalt driveway at 5765 N Lakeshore Dr. Doug recommended approval. Jon Riche made a motion to approve the application and it was seconded by Ken Stojeba. Mike and Steve received messages from an individual wanting to tear down the Coker residence which burned down. Someone will get in touch with the man and ask to him fill out a building application describing the work. This would expedite the process and include his agreement to repair any road damage caused throughout the process.

#### Security

Roy reported on a recent discussion among the board members regarding enforcing road and water violations. Also, the board is looking into increasing the hours for GCI Security on and off the water.

#### Gate

Rich Hirsch reported the most used code in June was by Matt Holloran. Rich stated that the use of this code is increasing and

asked to consider changing his code. The 2nd most used code was by Speedy Delivery. Rich looked at the instances of Speedy Delivery using the code and found that it was used by cars not associated with that company. The code has been canceled.



#### Monthly Sewer Fees

The monthly sewer fee for each residential property is \$72. If the payment is not received by the 21st of the month a 10% late fee is applied. To make sure your payment is always on time you should sign up for automatic withdrawal from your back account. The eaiest way is to set up automatic payments through your bank. Alternatively, you can download the Billing and Payment Options brochure from the website, http://www.laketishomingo.com/pwsd13, and fill out the form for automatic payment.

After you are set up for automatic payment, either through your bank or through PWSD#13, you can opt out of receiving monthly postcard invoices by sending an email message to pwsd13@charter.net with the message "I am now using automatic payments -- postcard invoices are no longer required."

At the intersection of Tishomingo Rd, and Hwy 21 Minnesota's St Peter Sand Co wants to create a quarry to blast, grind, and haul silica sand.

The Planning & Zoning Commission conducted a public hearing June 14 for Conditional Use Permit CU18046. The meeting was attended by hundreds of people. At the hearing the P&Z professional staff recommended denial of the permit. The Commission voted unanimously to deny the permit.

July 9 the Jefferson County council met and also voted unanimously to deny the permit.

# The Fight Is Not Over


Now the property owner and St Peter Sand Co have filed suit against Jefferson County to reverse the council decision.



# WATER ACTIVITIES RULES AND REGULATIONS

(Revised 2015 By LTPOA Board)

#### Ι. FISHING

- Fishermen must be accompanied by a lot owner except 1. by special arrangements made with the lake patrol.
- Fish may be taken using a rod or pole. Only three rods or 2. poles per person are allowed, and there is a three hook limit on each rod or pole.
- Trotlines and jugs are prohibited. 3.
- The maximum number/quantity of fish per take, creel, 4. catch or possession shall be according to the Tishomingo Anglers Association's current recommendations in accordance with the continuing effort to improve and modify each species and their population. These regulations are formulated after consulting our local fisheries biologist.

#### PATROL BOAT П.

- 1. The LTPOA patrol boat operator is responsible for water safety and enforcement of Water Activities Rules and Regulations and Boat Registration and Regulations.
- 2. The patrol boat will be operated in a safe and courteous manner and has the right-of-way on the lake at all times.

#### **BOAT & MOTOR IDENTIFICATION**

- All boats must be registered with the LTPOA and must be 1. the property of a lot owner.
- Registration stickers will be furnished for those boats in 2. compliance with the LTPOA Boat Registration Rules and Regulations. Stickers must be placed on the left (port) side of the craft near the block and lot identification.
- Boats of all types must have the owner's lot and block 3. number placed on each side of the craft in letters not less than three (3) inches in height. Placement should be toward the front of the boat if possible.
- IV. **BOATS** - All boaters must be in compliance with Missouri State Rules and Regulations
- The maximum boat length allowed is seventeen (17) feet 1. excluding pontoon boats.
- No boat shall be overloaded beyond the OBC rated 2. capacity, or have a motor that exceeds the OBC maximum rating.
- No hydroplanes, jet skis, inboard motor, or air boats 3 (swamp buggies) are allowed. All outboard motors must be propelled by a marine propeller, NO jet drives are allowed.

#### V. **PONTOON BOATS**

- Pontoon boats cannot exceed 24 feet in length. 1.
- No such type of craft shall be permitted unless the owner 2. has a residence at Lake Tishomingo.
- No such craft shall have any temporary or permanent 3. sleeping, cooking, sanitary or toilet facilities thereon. No enclosing or screening of craft.
- Pontoon boats are restricted to "No Wake" (a very slow 4. speed whereby the wake or wash created by the vessel would be minimal).

#### MOTORS VI.

1. No craft shall have attached a motor which exceeds a total of forty (40) horsepower.

# VII. MOTOR BOATING

- From 10.00 a.m. until 7:00 p.m. (prevailing time), 1. maximum speed allowed.
- From 7:00 p.m. until 10:00 a.m., all crafts shall be 2 restricted to "No Wake" (a very slow speed whereby the wake or wash created by the vessel would be minimal). 3.
- During ski hours all boats are to maintain a marine

pattern of counter-clockwise travel.

- Zigzagging, facing toward the stern while operating boat, 4. reckless speed, operating craft while intoxicated and any other form of careless or reckless operation is prohibited.
- Minimum clearance of freeboard from gunwale to the 5. surface of the water while operating shall be six (6) inches for any craft.
- Every craft must be equipped with an approved type of 6. life preserver for each person aboard.
- 7. Boats operating after dark must be properly lighted.
- 8. All boating must be at least 100 feet from shore.
- Right-of-way shall be in the following order: sailboats, 9. row boats, canoes, pontoons.
- 10. No boats are to enter swimming area under any circumstances.
- 11. Reduce speed of all craft while in coves or launch area to "No Wake" (a very slow speed whereby the wake or wash created by the vessel would be minimal)
- 12. If you see or think that anyone is in distress, make effort to help and notify patrol boat.

# VIII. SKI AND SURFBOARD SAFETY

- Skiing or surfboarding is permitted from 10:00 a.m. until 1. 7:00 p.m. (prevailing time).
- 2. Skier must wear an approved life saving belt or jacket at all times.
- Keep boat and skier 100 feet from shore while operating. 3
- All boats when pulling skiers must either be equipped 4. with a rearview mirror or have at least two occupants.
- 5. Travel counter clockwise at all times and circle counter clockwise when picking up a fallen skier.
- Never drive boat so that skier is closer than 50 feet from 6. any object.
- Take signal from skier only and never sit on gunwale of 7. boat.
- 8. Operators of boats pulling skiers must be at least sixteen (16) years of age.
- 9. Skiing from cove entrance is not permitted. Skiing should start and end up on the main body of the lake.

#### IX. SCUBA DIVING

- Any property owner or guest scuba diving must have card 1. signifying accredited course in techniques of diving.
- 2. Report to the patrol approximate area where you intend to dive from.
- Display diver flag on float or boat and stay within 100 3 feet of same. Boats and skiers to keep 150 feet from flag. Remove flag after dive.
- No scuba diving in ski lanes except when search and 4 rescue diving is being conducted.
- Fish and game Laws must be observed by divers. 5.

#### Χ. SWIMMING

- All swimmers must stay within fifty (50) feet of the 1. shoreline except as noted below.
- 2. Swimming from pontoon boats is permitted (for short periods of time) in the lane between swimming, 50 feet from shoreline, and the ski lanes, 100 feet from shoreline.

#### **BUOYS** XI.

No buoys/tethered objects may be used in Lake 1. Tishomingo without LTPOA approval.

## XII. RESPONSIBILITY

1. Lot owners will be held responsible for the actions of their guests.
